Excellence in Practice Categories:

- **Advanced Practice** - Masters prepared nurse in an advanced practice setting; clinical nurse specialist, certified nurse midwife, nurse practitioner, nurse psychotherapist, CRNA
- **Ambulatory Nursing** - Clinic, office and other ambulatory care settings, employee health, FQHC, occupational health, industrial health, infection control
- **Behavioral Health** - Behavioral health and substance misuse services
- **Case/Quality Management/Managed Care/Informatics/Infection Prevention** - Community or hospital case manager, quality management, risk management, infection prevention, patient safety, utilization management, and informatics
- **Critical Care** - Adult ICU/CCU, cath lab, special procedures
- **Emergency** - Emergency department, flight, ambulance, pre-hospital, urgent care, telephone triage
- **Home Health & Hospice** - Home health care settings, hospice, in-patient hospice
- **Long-Term Care/Rehabilitation** - Nursing home, gerontology, services for disabilities, rehabilitative services, subacute/transitional unit
- **Maternity/Women's Health** - Obstetrics/nursery, gynecology, women's health
- **Medical/Surgical** - Acute or chronic medical and surgical nursing specialties
- **Pediatrics** - Inclusive of school nurse, pediatrics, NICU, PICU, Peds ED, early childhood/early intervention services
- **Perioperative** - Preoperative, post anesthesia recovery, day surgery, operating room
- **Public Health/Community** - Public health, forensic, transplant coordinator, tele-health, parish and corrections/prison nursing

NOMINATION ESSAY QUESTIONS

The nomination form will ask you to provide responses to the following five (5) essay questions. Within the provided word counts, describe why you feel this nominee is deserving of the New Mexico Nursing Excellence Award. Please cite specific examples of accomplishments referring to the criteria listed for the specific award category. Describe how the person demonstrates caring that goes beyond the expected behaviors associated with providing competent and compassionate nursing care.

These essay responses must be blinded. This means the nominee's name is not included in any of the following responses. If the answers are not fully blinded, your nominee may not be eligible for judging.

1. **How does this nurse demonstrate outstanding delivery of patient care that contributes to positive patient outcomes? (30% scoring weight) 250 words max**
 - ❖ Assessment of client specific data, diagnosis, and health needs
 - ❖ Development of customized plan of care with the patient and family that respects a diverse patient population.
 - ❖ Implementation of nursing care using theory-based practice, scientific and technical skill
 - ❖ Evaluation of outcomes and proactive course correction as appropriate
 - ❖ Health teaching provided to patient and family
 - ❖ Self directed safe patient care and advocacy for patient and family

2. **How does this nurse participate in activities and practice that improve patient/client satisfaction? (25% scoring weight) 250 words max**
 - ❖ Assists in the orientation of new employees/students; serves as preceptor, mentor
 - ❖ Recognized as a professional role model; engages in innovative activities to improve patient outcomes
 - ❖ Demonstrates responsiveness, positive communication/collaborative skills, and caring relationships
 - ❖ Creates/supports a positive practice environment

3. **How does this nurse commit to the organization and its community through participation in patient care/community improvement efforts? (20% scoring weight) 200 words max**
 - ❖ Demonstrates knowledge transfer and dynamic integration with others on care team
 - ❖ Actively participates in quality improvement and patient safety activities
 - ❖ Develops or contributes to the development of health improvement assessment and plan

4. **How does this nurse encourage team cohesiveness/contribute to the healthcare team? (15% scoring weight) 200 words max**
 - ❖ Transfer of knowledge and dynamic integration with others on care team
 - ❖ Proactively shares knowledge and skills with others

- ❖ Participates in quality improvement and innovative patient safety activities
- ❖ Develops or contributes to the development of procedures/standards of care

5. **How does this nurse demonstrate personal growth in his/her professional practice?**
(10% scoring weight) 100 words max

- ❖ Active member of local, regional, state, or national nursing organization, association, and/or board of directors
- ❖ Assumes accountability for professional development (certification, pursuit of higher degree, etc.)

Important Instructions

In order for a nominee to be considered for an award, all information requested must be provided.

This includes:

- 1) A completed online nomination form from our website:

- 2) Payment of the \$100 Nomination Fee. With the payment of the nomination fee, Nominees receive a complimentary ticket for their dinner/entry to the event.

Please Note:

- A nurse may **not** be nominated again in the same category in which they have won previously.
- DO NOT provide identifying information in your essay. This is an anonymous process with all nominations blinded.
- The New Mexico Nursing Excellence Award Selection Committee reserves the right to place nominees in the category that best fits their nomination and/or enhances the nominee's ability to compete for the award.
